TOURNAMENT RULES

This Tournament will be certified by USBC and Governed by the General Playing Rules in Chapter 2 and the Rules in Chapter 6 of the USBC Rules Book and in addition the following Rules will be followed: The entrant whose names appear on the entry form or their authorized replacements, hereby agree that the JOLIET AREA USBC Association Officers and Agents shall be liable only to the extent of returning the entry fees if, and when these entrants shall be prevented from bowling the Tournament through premature termination of the tournament, this may be brought on by war, national emergency or emergencies or causes relating thereto or resulting there from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the Joliet Area USBC Association.

- 1) Entries will be opened to members of the **JOLIET AREA USBC ASSOCIATION. No one under the age of 18 can bowl in this tournament.**
- 2) **Mixed doubles teams must consist of one female bowler and one male bowler from the Joliet Area USBC Association. Multiple participation is allowed, but you MAY ONLY CASH ONCE WITH THE SAME PARTNER.**
- 3) Entrants must use their highest **JA USBC** certified league average regardless if bowled as a regular member or a substitute. Averages will be accepted in the following order:
 - a) Highest JA USBC previous regular or summer season average for at least 21 games. Average Book will be accepted as official.
 - b) If 'A' does not apply, entrant will use the current fall JA USBC Association highest average for the **2025 - 2026 season based on at least 12 games or more** as of October 17, 2025. Please bring the **Current** League standing sheet.
 - c) If none of the above applies, entrants shall bowl scratch using 220.
- 4) **LIMIT ON TEAM AVERAGE IS 440.**
- 5) Rule 304, 319 C will be enforced, but rules 319 a-2 & 319 E will be waived.
- 6) This JA USBC Association Tournament will be handicapped with an optional Scratch event. Handicap will be 90% of the difference of 220 and the bowler's highest league average. (See Above Tournament Rule #3.)
- 7) All fees must accompany the entry form. Mixed Doubles wishing to cross with each other must mail both entries in the same envelope to be assured of the same dates and time.
- 8) **Team captains are responsible for notifying TEAM members of the date & time of participation. Also, the Team Captain is responsible for notification of any mistake in scores within 24 hours after bowling.**
- 9) After an entry has been received and the dates assigned by the Tournament Director are accepted by the team captain, **NO FEES SHALL BE REFUNDED.**
- 10) Substitutes are allowed when a replacement is necessary. The Tournament Director must be advised of substitutions at least one hour before the scheduled bowling time. In case of an emergency after the game has started, a substitute, if one is available, shall be allowed to bowl. The combined scores will count. If no substitute is available, only the actual score of the frames bowled will count.
- 11) **Entries close 30 minutes prior to the last squad of the tournament (Oct. 25, 2025, @ 3:00 PM. Last entry accepted at 2:30 PM, providing openings are available.)**
- 12) Prize fund will be paid 100%. The prize ratio will be at least one prize for every six entries.
- 13) In case of a tie for Mixed Doubles Championship, Co-Champions will be declared. In case of a tie in any handicap or optional scratch place, prizes will be combined and then divided.
- 14) Ten minutes of practice time will be allowed—**NO PRACTICE ON ANY LANES WITHIN 2 HOURS OF THE SCHEDULED TIME TO BOWL. Practice starts 10 minutes before start of the squad!**
- 15) The Board of Directors of the JOLIET AREA USBC Association has the authority to make decisions regarding anything not covered by these Tournament Rules.
- 16) **All contestants are to report to the lanes thirty minutes before the scheduled time to bowl. Proof of certification must be shown.**
- 17) **EACH PARTICIPANT IS EXPECTED TO EXHIBIT GOOD SPORTSMANSHIP DURING PARTICIPATION. THE USE OF FOUL LANGUAGE OR IMPROPER CONDUCT WILL RESULT IN THE BOWLER RECEIVING (1) ONE WARNING. ADDITIONAL VIOLATION WILL RESULT IN IMMEDIATE DISQUALIFICATION OF THE BOWLER FROM THE TOURNAMENT.**
